Application **MUST** be filled out in full and signed by the Hunter and the Landowner. Must be legible.

Applications will be turned over to the Chief of Police for review and returned to our office as soon as complete.

**Permission for Hunting on Private Land**

20 -20 ' Season – *Valid*

Permission is hereby granted to the undersigned sportsperson for the hunting on land owned by the undersigned landowner or their agent for the date(s) listed and according to the conditions stated on the permit in compliance with Village of Valley View Ord #618.16:

- (1) The parcel of land **MUST** be 2 acres or more.
- (2) Allowed only for residents or others with land owners permission.
- (3) Proper permit and consent credentials shall be on hunters possession during activity.
- (4) Bow hunting shall take place from a raised platform at least 5 feet high and at least 300 feet from a residential dwelling or property building structure.

In accepting this permit, I agree to assume and release the landowner from any or all liability for personal injuries, property damage, or for the loss of life or property resulting from, or in any way connecting with the issuance of this permit. \_\_\_\_\_

Ohio Revised Code 1533.181: Exemption from liability to recreational users.

(A) No owner, or Lessee, or occupant of premises:

- (1) Owes any duty to a recreational user to keep the premises safe for entry or use:
- (2) Extends any assurance to a recreational user, through the act of giving permission, that the premises are safe for entry and use:
- (3) Assumes responsibility for or incurs liability for any injury to person or property caused by any act of a recreational user.
