NEW BUSINESS FROM COUNCIL

COUNCILMAN BOROWY READ THE FOLLOWING STATEMENT:

"IN REGARDS TO THIS YEARS ELECTION, I WANTED TO LET OUR RESIDENTS KNOW HOW GRATEFUL AND APPRECIATIVE MY FAMILY AND I ARE FOR THEIR SUPPORT. AS SOME OF YOU MAY KNOW, MY MOTHER FOUGHT A HARD AND COURAGEOUS BATTLE WITH ALS. SHE WAS BURIED THE DAY BEFORE THE ELECTION.

DURING HER STRUGGLE, MY MOM AND FAMILY WAS MY NUMBER ONE CONCERN. I FAILED TO CAMPAIGN. I DID NOT GO DOOR TO DOOR TO MEET WITH OUR RESIDENTS. I DID NOT MAIL EVEN A SINGLE FORM OF LITERATURE OUT.
